INVITATION FOR BIDS**

Sealed Bids will be received by the **Mexia Water System** until **Thursday, September 25, 2025, at 10:30 A.M., local time**, for the work according to Specifications and Contract Documents on file in the office of the Owner, the improvements hereinafter described. No bids will be received after the time set forth hereinabove; and the Bids will be publicly opened and read.

The Bid Documents will be opened at **Mexia Water System on Thursday, September 25, 2025, at 10:30 A.M., 4455 Highway 84 Frisco City, AL 36445. If your Bid Documents are mailed, they should be received prior to Thursday, September 25, 2025, at 10:30 A.M. at the Mexia Water System office.**

The work of providing labor, equipment, and material for **Mexia Water System DWSRF Infrastructure Improvements Project – Contract 5 / Back-Up Well Pump and Pipe Installation Project - DWSRF PROJECT NO. FS010356-01.**

The principal items of work are detailed herein below:

1. Install necessary Pump, Motor; Concrete Pump Pedestal Foundation and Piping Assembly from Back-Up Well to Existing Well #1
2. Provide required piping for Connection of the Back-Up Well to the Existing Well #1 Discharge Header
3. Provide Electrical Connections
4. Provide Leveling on Motor Base Plate to Concrete Pedestal and Perform Vibration Analysis on Existing Well #1 and Back up Well

The Contract may be awarded to the lowest and responsive Bidder. The successful bidder must furnish a Performance Bond for one hundred (100%) of the bid amount and a Payment Bond for one hundred (100%) percent of the bid amount and must secure his bond from a bonding company's representative or agent in the State of Alabama.

No bid may be withdrawn after the time for opening bids has passed. The Owner reserves the right to hold the bids for a period of sixty (60) days after the date of receiving the Bids.

The Contractor is hereby advised that **TIME IS OF THE ESSENCE** on this project and that the contract time of **180** consecutive calendar days total and noted restrictions shall be strictly observed. **LIQUIDATED DAMAGES WILL BE ASSESSED IF CONTRACT TIME IS EXCEEDED.** The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages.

The Owner reserves the right to reject any or all bids, to waive any informality in any bid, and to accept any bid considered advantageous to the Owner.

The contractor shall note that funds for this project are provided through DWSRF (Drinking Water State Revolving Loan Funds) and ARPA Funds. All Applicable Federal Guidelines must be met. **There will be no Pre-Bid meeting.**
