

**NOTICE TO CONTRACTORS  
INVITATION FOR BIDS**

Sealed Bids will be received by the Sewage Disposal Board of the City of Red Bay until May 16, 2024, at 2:00 P.M. local time, for furnishing all equipment and doing the work according to Specifications and Contract Documents on file in the office of the Owner, the improvements hereinafter described. No bids will be received after the time set forth hereinabove; and the Bids will be publicly opened and read. The Bid Documents will be opened at The Red Bay City Hall on May 16, 2024, at 2:00 P.M., 203 4<sup>th</sup> Avenue SE, Red Bay, Alabama 35582. If your Bid Documents are mailed, they should be received prior to May 16, 2024 at 2:00 P.M. at The City of Red Bay, 203 4<sup>th</sup> Avenue SE, Red Bay, Alabama 35582.

The work of providing labor, materials, and equipment for the Proposed City of Red Bay Sewer Lift Station Telemetry Upgrade Project.

The principal items of work are detailed herein below:

1. Furnish and install Telemetry monitoring equipment for seventeen (17) Sewer Lift Stations and the Effluent Flow at the WWTP Lagoon.
2. Provide a minimum of one (1) day of training.

No refunds will be made except to Prime Contractor Bidders, which shall be refunded for one bid set.

The successful bidder must furnish a Performance Bond for one hundred (100%) of the bid amount and a Payment Bond for one hundred (100%) percent of the bid amount and must secure his bond from a bonding company's representative or agent in the State of Alabama.

No bid may be withdrawn after the time for opening bids has passed. The Owner reserves the right to hold the bids for a period of sixty (60) days after the date of receiving Bids.

The Contractor is hereby advised that TIME IS OF THE ESSENCE on this project and that the contract time of 60 consecutive calendar days total and noted restrictions shall be strictly observed. LIQUIDATED DAMAGES WILL BE ASSESSED IF THE CONTRACT TIME IS EXCEEDED. The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages.

**The Contractor shall note that funds for this Project are provided through CWSRF (Clean Water State Revolving Funds) and Appalachian Regional Commission (ARC) monies. All applicable Federal guidelines must be met. There will be no Pre-Bid Meeting.**

The Owner reserves the right to reject any or all bids, to waive any informality in any bid, and to accept any bid considered advantageous to the Owner.
