The work of labor for **Russellville Waterline Relocation Project Along Highway 243 - ALDOT Project No. BR-0243 (504)** will be let under one Contract.

The principal items of work are detailed herein below.

Principal Work:

1. Approximately 1,000 L.F. of 2" Water Line Relocation
2. Water Meter Resets
3. Valve Box Reset
4. 350 L.F. of Directional Bore (Creek Crossing)

The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages. All applicable Federal Guidelines must be met. Davis – Bacon Wage Rate, Beason Hammon / E-Verify Certification, and Equal Opportunity requirements must be met.
