Sealed Bids will be received by the Water Works and Sewer Board of the City of Winfield, AL until **Friday, March 15, 2024, at 10:00 A.M.**, local time, for the work according to Specifications and Contract Documents on file in the office of the Owner, the improvements hereinafter described. No bids will be received after the time set forth herein above; and the Bids will be publicly opened and read.

The Bid Documents will be opened at **The Water Works and Sewer Board of the City of Winfield on Friday, March 15, 2024 at 10:00 A.M., 160 City Hall Street, Winfield, AL 35594. If your Bid Documents are mailed, they should be received prior to Friday, March 15, 2024, at 10:00 A.M. at The Water Works and Sewer Board of the City of Winfield, 160 City Hall Street, Winfield, AL 35594.**

The work of labor, equipment, and material for the **Winfield Water System Infrastructure Improvements Project – Ember Drive and Smith Road Water Booster Pump Station Installations - DWSRF PROJECT NO. FS010243-02**

The principal items of work are detailed herein below:

1. Two Water Booster Pump Stations
2. Installation of 6" PVC Water Line, Fire Hydrants and Piping Connections
3. One (Open Cut) Road Crossing
4. Misc. Appurtenances

The successful bidder must furnish a Performance Bond for one hundred (100%) of the bid amount and a Payment Bond for one hundred (100%) percent of the bid amount and must secure his bond from a bonding company's representative or agent in the State of Alabama.

No bid may be withdrawn after the time for opening bids has passed. The Owner reserves the right to hold the bids for a period of sixty (60) days after the date of receiving Bids.

The Contractor is hereby advised that **TIME IS OF THE ESSENCE** on this project and that the contract time of **90** consecutive calendar days total and noted restrictions shall be strictly observed. **LIQUIDATED DAMAGES WILL BE ASSESSED IF CONTRACT TIME IS EXCEEDED.** The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages.

The Owner reserves the right to reject any or all bids, to waive any informality in any bid, and to accept any bid considered advantageous to the Owner.

The contractor shall note that ARPA funds for this project are provided through DWSRF (Drinking Water State Revolving Funds). All Applicable Federal Guidelines must be met. **There will not be a Pre-Bid meeting.**
