INVITATION FOR BIDS

Sealed Bids will be received by the City of Red Bay until October 20, 2022, at 10:00 A.M., local time, for furnishing all labor, materials, and equipment and doing the work of constructing, according to Plans, Specifications and Contract Documents on file in the office of the Owner, the improvements hereinafter described. No bids will be received after the time set forth hereinabove, and the Bids will be publicly opened and read. If your Bid Documents are mailed, they should be received prior to 10:00 a.m. of the Bid Date at the City of Red Bay 203 4th Avenue SE, Red Bay AL 35582.

The work of constructing City of Red Bay 2022 Road Resurfacing Project will be let under one Contract that includes various areas. Each area will be considered based on its overall cost. The principal items of work are detailed herein below. Road Resurfacing along Gober Drive, Bates Drive; Marie Drive; 10th Street N.E.; Second Street S. W.; Misc. Road work in the Brookwood Subdivision and Three (3) Alley Way Locations.

LIQUIDATED DAMAGES WILL BE ASSESSED IF THE CONTRACT TIME IS EXCEEDED. The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages.
