Sealed Bids will be received by the City of York until **March 5, 2024, at 10:30 A.M., local time**, for the work according to Specifications and Contract Documents on file in the office of the Owner, the improvements hereinafter described. No bids will be received after the time set forth hereinabove; and the Bids will be publicly opened and read.

The Bid Documents will be opened at **The City of York on March 5, 2024, at 10:30 A.M., 607 2nd Avenue, York, AL 36925. If your Bid Documents are mailed, they should be received prior to March 5, 2024, at 10:30 A.M. at The City of York, 607 2nd Avenue, York, AL 36925.**

The work of providing labor, equipment, and material for the **York Storm Culvert Replacement and Road Rehabilitation Project – ALDOT Project No. RAA-60-2023.**

The principal items of work are detailed herein below:

1. 24" (Class 3 R.C.) Roadway Pipe-140 L.F.
2. 15" (Class 3 R.C.) Roadway Pipe-80 L.F.
3. Planing Existing Pavement (1.10" thru 2.0" Thick) – 1,420 SY
4. Misc. 4" Thick Concrete Sidewalk Replacement
5. Superpave Bituminous Concrete Wearing Surface-140 Tons
6. Superpave Bituminous Upper Binder Layer- 200 Tons
7. Traffic Control
8. Striping

The successful bidder must furnish a Performance Bond for one hundred (100%) of the bid amount and a Payment Bond for one hundred (100%) percent of the bid amount and must secure his bond from a bonding company's representative or agent in the State of Alabama.

No bid may be withdrawn after the time for opening bids has passed. The Owner reserves the right to hold the bids for a period of sixty (60) days after the date of receiving the Bids.

The Contractor is hereby advised that **TIME IS OF THE ESSENCE** on this project and that the contract time of **50** consecutive calendar days total and noted restrictions shall be strictly observed. **LIQUIDATED DAMAGES WILL BE ASSESSED IF CONTRACT TIME IS EXCEEDED.** The Contractor may apply for an extension of time in accordance with the provisions of the contract; however, such an extension must be approved prior to the contract completion date to avoid the imposition of liquidated damages.

The Owner reserves the right to reject any or all bids, to waive any informality in any bid, and to accept any bid considered advantageous to the Owner.
